THIS IS TO INFORM YOU that the land area at Makua and Kahanahaiki Waianae, Oahu identified as parcels 01 (por of), 02 (por of), 08 (por of), 09, 10 (por of), of Tax Map Key 8-1-01 and parcels 01, 02 (por of), 09, 10, 22 of Tax Map Key 8-2-01 are owned by or under the Jurisdiction of the State of Hawaii.

Anyone placing any vehicles and/or structures, including but not limited to a dwelling, lean-to, shed, tent, campsite; and anyone occupying camping, and/or residing on said land without the written authorization of the Board of Land and Natural Resources, State of Hawaii, is encroaching upon public lands in violation of Chapter 171-6, Hawaii Revised Statutes, and shall be subject to a fine of up to \$500 per day, plus charges for administrative costs incurred by the Department of Land and Natural Resources and for payment of damages.

ANYONE CAMPING OR RESIDING OR PLACING ANY STRUCTURE INCLUDING BUT NOT LIMITED TO A DWELLING, LEAN-TO, SHED OR TENT TO CAMP OR RESIDE ON SAID LAND WITHOUT A PERMIT OR OTHER WRITTEN AUTHORIZATION OF THE BOARD OF LAND AND NATURAL RESOURCES, STATE OF HAWAII, IS IN VIOLATION OF SECTIONS 13-146-34 AND 13-146-51, HAWAII ADMINISTRATIVE RULES, AND SHALL BE GUILTY OF A PETTY MISDEMEANOR.

NOTICE TO VACATE is hereby given to all persons occupying, camping and/or residing on said lands without the written approval of the Board of Land and Natural Resources, State of Hawaii, that you must vacate said lands immediately and remove all structures, vehicles and personal belongings placed thereon.

ANY AND ALL PERSONS FOUND OCCUPYING, CAMPING AND/OR RESIDING UPON SAID LANDS AFTER 6:00 A.M., MONDAY , APRIL 15 , 1996, shall be SUBJECT TO ARREST AND PROSECUTION FOR TRESPASSING AND, ALSO, SHALL BE SUBJECT TO A FINE UP TO \$500.00 PER DAY PLUS ADMINISTRATIVE COSTS AND DAMAGES, FOR VIOLATIONS OF THE PROVISIONS OF CHAPTER 171-6, HAWAII REVISED STATUTES.

FURTHERMORE, ANY AND ALL FIXTURES, EQUIPMENT, STRUCTURES, VEHICLES AND PERSONAL BELONGINGS PLACED, MAINTAINED AND/OR FOUND ON SAID LANDS AFTER 6:00 A.M., MONDAY , APRIL 15 , 1996, SHALL BE CONSIDERED ABANDONED AND SHALL BE DISPOSED BY THE STATE OF HAWAII AT THE FORMER OWNER'S COST AND EXPENSE PURSUANT TO CHAPTER 171-6, HAWAII REVISED STATUTES AND SECTION 13-146-7, HAWAII ADMINISTRATIVE RULES.
